Dr. S.Vanaja, is engaged as Contract Medical Practitioner (Full Time, 2<sup>nd</sup> tenure) Specialist (Pediatician) at ICF Hospital for a period of one year or less from the date of entering into fresh contract on 25.04.2019 against the Group B revenue post of 'VO' temporarily being operated in Medical department.


The contract is under the following terms and conditions:

1. The engagement will be purely on contract basis for a period not exceeding one year or less. She will not have any claim or right for extension of contract. This Administration may however, review the same there after.
2. No Private practice will be allowed.
3. A sum of ₹ 1,05,000/= p.m. will be paid as remuneration. This remuneration is inclusive of ₹ 5,250/- as House Rent Allowance, (to be disallowed if provided with Government accommodation) and ₹ 3,712/- towards Transport Allowance.
4. The CMP can terminate the contract for betterment of her career or on any other grounds by giving 15 days notice to the Railways. The contract can also be terminated by the Railways at any time by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
5. Normally, Sundays and National Holidays will be off and in addition, she will be allowed two days of authorized absence per month, to be availed anytime during the contract to the extent earned without detriment to the other terms of her engagement.
6. For absence beyond the stipulated period an amount of ₹ 3,500/- will be deducted for each day of absence.
7. She will attend to all normal tasks, which any medical practitioner is conventionally doing and also attend to emergencies and accidents.
8. She can issue sick certificates for a period up to 7 days beyond which the certificate issued by her should be certified by a regular Railway Medical Officer.

9. She should not make medical recommendation of any kind referred to in Para 559 to 564 of Indian Railway Medical Manual, 2000.
10. She should not perform administrative work like Pre-Employment or Periodical Medical examination and will not have any financial powers.
11. She is eligible for one set of first class complimentary pass for self and family members after completion of three months service from the date of engagement under contract.
12. She can avail free medical treatment for self only, except the operations categorized as 'Special' in Para 622 (8) of IRMM 2000 and treatment normally available at Super Specialty Centers from her respective Zonal Railway during the currency of the contract.
