Shri. PATEL C.G. (SC), Emp.No. 838330, Technician Gr-2/Machinist General, Shop/T.No. 303/7017 has been Compulsorily retired from service w.e.f.19/06/2018 on pay Rs.25, 500/- in Level-4 as a disciplinary measure under DAR vides office order No. PB/S4C/05/1045 dated: 20/06/2018.

On appeal the penalty of Compulsory Retirement from service ordered in respect of Shri. PATEL C.G is modified to that of "Reduction to lower post as Helper on pay ₹.24, 900/- in Level -1 (NR) for a period of three years from the date of joining duty on reinstatement. On expiry of such period, this will not have the effect of postponing the future increment of Pay and seniority".

Consequently, Shri. PATEL C.G, Emp.No. 838330 is reinstated into service as Helper on pay of Rs.24, 900/- in Level-1 and posted to Shop-10 with effect from 20/12/2018.

The intervening period between the date of compulsory retirement from service and the date of joining duty on re-instatement i.e from 19/06/2018 to 19/12/2018 is treated as DIES-NON.
