In terms of Para 9.2.2.1(iii) of Railway Board's letter NO.2010/E(sports)/4/1(policy) dated 31/12/2010 modified vide Railway Board's letter No.2012/E(Sports)/4(1)/3/OTP/DOPT dated 23/05/2013, Sports persons are eligible for second and subsequent out of turn promotion if they represent Indian Railways in the Senior National Championships on three occasions with medal winning performance in each Championship. Sri.S.BASKARAN, Emp.No.814531 has won the following championships:-

- (i) Represented Indian Railway in 8th Senior National Body Building Championship held at Gujarat from 27/02/2015 to 01/03/2015 and won 1st place.
- (ii) Represented Indian Railway in 10th Senior National Men's Body Building Championship held at Gurugram, Haryana from 02/03/2017 to 04/03/2017 - Second place
- (iii) Represented Indian Railway in 11th Senior National Men's Body Building Championship held at Pune, Maharashtra from 23/03/2018 to 25/03/2018 and won 1st place.

Based on the above outstanding performance, General Manager has approved for grant of second out of turn promotion to Sri.S.Baskaran, Emp.No.814531 Tech.Gr.1/Welder as Sr.Tech/Welder W.E.F. 25/03/2018 by relaxing 3 years service condition against a special supernumerary post of Senior Technician/Welder (Level-6). Accordingly, he is promoted as Senior Technician/Welder on out of turn basis W.E.F. 25/03/2018 and his pay is fixed as under Rule1-1313 R-II :-

The post of Technician.Gr-1/Welder in Level-5 vacated by the above employee is being kept unfilled as long as the supernumerary post of SR.Tech is in operation.

Shri.Baskaran is found suitable for the post of Sr.Tech/Welder vide select list No.PB/CON/213/424/XVIII dt. 30/07/2018 .

Shri.Baskaran should assume higher responsibilities of the post of Senior Technician/welder.

His seniority will be assigned in the grade of Senior Technician/Welder w.e.f.25/03/2018.

He will be on probation for a period of twelve months. The probation period will commence from the date of issue of this order as the above employee is given retrospective promotion. Further continuance in the promoted grade will be subject to his satisfactory completion of the period of probation.
