

3. They are not eligible for joining time, TA/Transfer grant, pass etc., as the transfer is ordered at their own request.
4. They will retain their lien in ICF/Chennai till such time they are absorbed permanently in CRW/MCS/E.Co.Rly.
5. They should vacate the railway quarters if any allotted to them, within the stipulated period.
