Gr.-III has been accepted by the Competent Authority in ICF vide letter No.PB/S3/61/30/11/Vol.IV dt.16/02/2012 and NWR letter No. 939E/1/Elect./IRT/Tech.III/174, dt. 31/07/2018, is relieved with immediate effect after working hours to report to CWM/E/North Western Railway/Ajmeer.

The above Inter-Railway one way transfer is ordered subject to the following conditions.

1. He will rank junior most to all permanent, officiating and temporary Tech.Gr.III in Level-2 in new seniority unit to which he is posted on the date of his joining.
2. He should not seek re-transfer to ICF at a later date.
3. He is not eligible for joining time, TA/DA/Transfer Pass, Composite Transfer grant etc. as the transfer is ordered at his own request.
4. He will be governed by general rules and regulations about his service conditions issued by the administration from time to time.
5. His lien will be maintained in ICF for a period of two years.
6. The employee is fit in A-3 medical category.
7. There is no DAR/Vigilance case pending/contemplated against the employee as on date.
8. He is not residing in Railway Quarters in ICF.

He has been relieved vide instructions contained in Railway Board's letter No. E(NG)- 2001/TR/16 dated 21.11.2001.
