

The Mutual Transfer is subject to the flowing conditions:

1. Shri. Yogendra Kumar will be assigned seniority in the new seniority unit to which he is transferred as per the extant orders applicable to such mutual transfer ( i.e.he will retain his own seniority or take the seniority of the other whichever is lower)
2. He will be governed by general rules and regulations about his service conditions issued by the administration from time to time.
3. He is not eligible for joining time, TA, Transfer grant, Transfer Pass etc., as the transfer is ordered at his/her own request.
4. In terms of Rule 228 of IREC Vol.I his/her lien with parent Railway will be retained until he/she is permanently absorbed in ICF.
5. He should not seek retransfer to his/her parent Railway at a later date.
6. He has declared that he is not living in Railway Government accommodation.
7. There is no Vigilance /DAR cases pending or contemplated against him.
8. He is covered under Pension Rule 1993 / New Pension System in terms of Railway Board letter No. F(E)III/2003/PNI/24 dated 31 /12 2003.
