
2. The financial upgradation under MACP scheme is purely personal to them and shall have no relevance for their seniority position. ie. this will not confer any seniority benefit.

3. Grant of higher level under the MACP scheme shall be conditional to the fact that the employee while accepting the said benefits shall be deemed to have given their unqualified acceptance for regular promotion on occurrence of vacancy subsequently.

4. The employees may exercise option if they want his pay to be fixed from the date of accrual of next lower grade increments, in terms of Rule 1313 R-II, within one month from the date of order. Any option received after one month will not be entertained under any circumstances. They are also advised that the option once exercised shall be final.

5. The financial upgradation entitles the employees concerned to avail certain benefits which are linked to the pay drawn by them.
