


2. His pay has been fixed duly counting the training period for the purpose of drawl of annual increment in terms of Railway Board's letter No.E(NG)/90/ICI/I dt.04/02/1991.
3. Pay increased from ₹ 35400/- to ₹ 36500/- for a period from 01/07/2018 to 07/09/2018 is only notional basis and hence payment made during the period as annual increment on actual basis may be recovered.
4. His service is purely temporary, the first one years of which will be on probation. He will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction to the post which he holds or the expiry of the officiating vacancy or is due to his physical or mental incapacity or due to the removal or dismissal as a disciplinary measure after compliance with the provision of clause-2 of the Article 311 of the Constitution of India. Otherwise his service is terminable on 14 days notice. However, the Appointing Authority reserves the right of termination of his services forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying her the pay and allowance for that period.
5. He should not resign or quit employment except with the previous consent in writing of the competent authority.
6. In terms of bond executed by him at the time of commencement of for App.JE/Works against Intermediate Apprentice quota, he should serve the Railways for a period of 5 years from the date of absorption failing which he should refund the entire stipend received during the training plus 12 ½ % interest representing the cost of training.

7. He may be governed by such other general conditions as may be laid down from time to time.

8. All other conditions stipulated in the office order No.PB/S1A/1516 dt.06/09/2017 remain the same.
