The under mentioned candidate engaged as Substitute in erstwhile Group-D category in pay band Rs.5200-20200+1800 grade pay whose name was excluded in the provisional select list No.PB/CON/49/2 dated 12/06/2009 due to the pending criminal case against him has now been included in the select list vide letter No.PB/CON/49/2 dated 12/09/2018 consequent on his acquittal from the criminal cases. He is interpolated between Smt.K.Poomani, Emp.No-837767 and Shri.T.krishnamurthy, Emp.No-837644.

As such, in terms of Para 1515 of IREM-I, he is granted temporary status as Railway Servant on completion of 120 days of continuous service and absorbed against regular post of Helper on existing pay in Level-1 (PB Rs.5200-20200+1800GP), on par with the date of regularisation of his immediate junior Shri.T.krishnamurthy. The above post have been upgraded as Group-C, vide Board letter No.PC-VI/2009/RSRP/4 dated 08/01/2010.

His services is purely temporary, the first two years of which are on probation. He will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction of the post which he hold or due to the expiry of the officiating vacancy or is due to his physical or mental incapacity or due to removal or dismissal as a disciplinary measure after compliance with the provision of Clause-2 of the Article-311 of the Constitution of India. Otherwise his service is terminable on 14 days notice on either side. However, the Appointing Authority reserves the right of termination of his services forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying him the pay and allowance for that period.

His continuance in service is subject to his fulfilling such other general conditions of service, as the case may be as laid down from time to time. His seniority will be assigned along with his batch of substitutes.

If at any later date the certificates submitted by him in support of his educational, community details etc., are found not to be genuine he is liable to be removed from service without notice. He will if required, be liable for military service in the Railway Engineering Units of the Territorial Army for a period of seven years and eight years in the Territorial Army Reserve or for such period as may be laid down in this behalf from time to time.

He is governed by the NEW PENSION SCHEME in terms of Board's letter No.F(E)III/2003/PNI/24 dated 31/12/2003.
