The under mentioned candidates, who have been empanelled for Group 'C' appointment on Compassionate grounds vide panel No. PB/CON/128/Gr.C/Vol.XII Dt.13/08/2018 are appointed as Tech.Gr.3/ Trainee Carpenter (Level-02). As they do not possess any Technical qualification, they have to undergo 3 years training ( 1 year in TTC and 2 years in shop floor). On appointment as Tech Gr.3/Trainee initially they are deputed to undergo one year training at TTC from the date of their appointment as Shown below.

On successful completion of one year training at TTC, they will be further deputed for 2 years on the job shop floor training.

During the training period they shall draw 7<sup>th</sup> PC stipend pay of Rs.18000/- + DA with effect from the date noted against them. On completion of training, they will be subjected to trade test and on passing of which they will be absorbed as Techn.Gr.3/Carpenter.

During the training period the leave may be restricted as per procedure Order No.03/2004 dt.28/06/2004. In case of any trainee availing leave beyond the permissible limits mentioned in procedure order, the period of training shall be extended to the extent of leave availed in excess of the prescribed limits.

If at any later stage, the certificates submitted by them in support of their educational qualification, community details etc. are found to be not genuine, they are liable to be removed from service without any notice.

In terms of Railway Board's letter No.F(E)111/2003 PNI/24, Dt.31.12.2003, They are governed by "NEW RESTRUCTURED DEFINED CONTRIBUTION PENSION SYSTEM".

They will be responsible for the care of Government money, goods and stores and any property that may be entrusted to their care in the discharge of their official duties.

No request for Inter-Railway Transfer will be entertained during the period of five years service.

In all other matters not specifically provided for in the recruitment rules, they will be governed by the provisions of the Indian Railway Establishment Code, Manuals and other extant orders as amended or issued from time to time.

They will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in this behalf from time to time.

They have been declared fit in B-2 medical category.

The above employees declared that they are not living in Government Accommodation.
