1. He will take his seniority in the new seniority unit as per Para 312 of IREM Vol.I. He will rank junior to all the permanent/temporary/ officiating Tech.Gr.3/Fitter in Level-2 on the date of joining in CRW/Hubli/South Western Railway..
2. He should not seek re-transfer to his parent railway at a later date.
3. He is not eligible for joining time, TA/Transfer grant, pass etc., as the transfer is ordered at his own request.
4. He will retain his lien in ICF/Chennai till such time he is absorbed permanently in CRW/Hubli/South Western Railway.
5. He should vacate the railway quarters if any allotted to him, within the stipulated period.
