The under mentioned employees who were initially allotted with Fitter General in QSE quota to the post of Technician Gr.3 could not be accommodated as there is a reduction of man power requirement in the said trade. Hence option was called for, from them for allotment of Electrical trade if they were willing. As they had opted for allotment of Electrical trade, their trade is now re-allotted from FGL to the post of Technician Gr.3/ Electrical, Level 2 (including Crane Drivers) (6th PC pay band Rs.5200-20200 + 1900 Grade pay) against 25% QSE quota and deputed for training at TTC and Shop floor and on passing the requisite trade test they are here by promoted to the post of Technician Gr.3/Electrical (including Crane Drivers) against 25% QSE quota and posted to Shops indicated against each with immediate effect.


