The services of Shri.SURESH KUMAR MAURYA, E.No.875341, Track Maintainer Gr.IV, Unit.No.77/2 (date of birth:15-08-1993 and date of appointment: 28/01/2016) of the Civil Engineering Department on pay ₹ 19100/- in Level-1 of 7th CPC Pay Matrix whose technical resignation is accepted by the competent authority in terms of Rule 302 of Indian Railway Establishment Code, Volume-I is relieved from ICF on 09/10/2018 after working hours and directed to report APO, Personnel Branch, Divisional Office, Central Railway, Mumbai to take up appointment to the post of Technician Gr.3 in Level-2 in Central Railway selected through RRB, Mumbai as per Letter No.BB.P.RECT CL.III RRB TR TECH III 46/50 dt:20/09/2018. His technical resignation is accepted with the following terms and conditions.

- i. His lien will be maintained in ICF for a period of two years in terms of Rule 241 of IREC Vol.I.
- ii. In terms of Para 1405 of Indian Railway Establishment Manual Vol.I, his lien will be maintained in ICF for a period of 2 years. In exceptional circumstances, the lien will be extended for a period of one more year. If the employee does not report back to this administration within the lien period of 2 years or extended lien period of 3 years as the case may be, it will be deemed that he has resigned from Railway service on completion of lien period.
- iii. He should surrender RC Pass, Identity Badge, Medical Card and materials in his possession.
- iv. He should vacate the Railway quarters, if any in occupation.
- v. He will be governed by general rules and regulations about his service conditions issued from time to time

2. The above mentioned employee was appointed on 28/01/2016 through RRC, Chennai and his qualifying service in ICF is 2 years, 8 months and 11 days as on the date of acceptance of technical resignation. No terminal benefits have been granted to the employee.

3. In terms of Railway Board's letter No.F(E) III 2003 PN1/24 dt.31/12/2003, the employee is covered under New Pension Scheme. His PRAIS No. is 110037232971.

4. There is no D.A.P./Vigilance case pending against him as on the date of relief.
