कार्यालय आदेश संख्या OFFICE ORDER No. PB/S2/1824

Shri.S.SUNDARAM, Emp.No.803604, Sr. Section Engineer/CSU, Unit-82A of the Mechanical Department has been compulsorily retired from service with effect from 28/06/2018 on Pay Rs.53600/-in level-7 as a disciplinary measure vide this office order No.PB/S2/1079 dated 28/06/2018.

On appeal, the penalty of compulsory retirement from service ordered in respect of Shri.S.SUNDARAM is modified to that of reduction to lower stage by two stages i.e. from Rs.53600/- to Rs.50500/- in Level-7 of RSRPR 2016 for a period of three years from the date of joining duty. On restoration of penalty this will have the effect of postponing the future increments of pay.

Consequently, Shri.S.SUNDARAM, Emp.No.803604 is reinstated as Sr. Section Engineer on Pay Rs.50500/- in Level-7 and posted to Shop-82A with effect from 05/10/2018.

The intervening period from the date of Compulsory retirement from service to the date prior to re-joining duty i.e. from 28/06/2018 to 04/10/2018 is treated as DIES-NON.
