

Shri.C.ELAMARAN, Emp.No.658161, (D.O.B.01/06/1963), (D.O.A. 17/11/1988), Ex-Inspector.Gr.1/ Ex-Cadre Shop/T.No.82A/0180, was compulsorily retired from service on 14/12/2016 as a disciplinary measure vide O.O.No.PB/S2/1935 dt.13/12/2016 and O.O.No.PB/S2/500 dt.13/19.03.2018. The penalty of compulsory retirement is modified by the Revising Authority and Shri.C.ELAMARAN is re-instated into service as Tech.Gr.2/Fitter/GI and posted to Shop-19 (T.No.7070) on pay Rs.25,500/- in Level-4 of RSRPR-2016 on 06/10/2018 with a penalty of "Reduction at lower post as Tech.Gr.2 on pay Rs.25,500/-in Level-4 of RSRPR 2016 for a period of three years from the date of joining duty on re-instatement. On restoration of penalty, this will have the effect of postponing the future increments of pay and seniority".

The intervening period between the date of compulsory retirement from service and the date prior to joining duty on re-instatement i.e. from 15/12/2016 to 05/10/2018 is treated as DIES-NON.
