Non-qualifying service includes EOL, UA, Dies-Non, etc. Calculations for pensionary benefits will be based on the qualifying service rendered. Even if for any of the above employees the date of temporary status is indicated against date of appointment, their qualifying service will be reckoned from the date of regular appointment and also 50% of Temporary status service will be added to total regular service for calculation of pensionary benefits. The employees are advised that in case they have any doubt about inclusion or otherwise of any spell of previous service etc., they should contact the cadre section with documentary evidence within one month from the date of issue of this order, so that the discrepancy can be sorted out. No representation will be entertained after one month.

The employees, who are eligible to join the Retired Employees Liberalized Health Scheme, will be automatically enrolled into the scheme. However, if any employee is unwilling to join the Scheme can opt out of the same by giving a letter in writing three months before the date of retirement. It is reiterated that once the employee opts out of the Scheme, he/she will not be eligible for joining the scheme at a later date.
