She will be charged against the vacancy available in the Administration Department (Unit 70A).

Her service is purely temporary, the first two years of which she will be on probation. She will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction to the post which she holds or the expiry of the officiating vacancy or is due to her physical or mental incapacity or due to the removal or dismissal as a disciplinary measure after compliance with the provision of Clause-2 of the Article 311 of the Constitution of India. Otherwise her services are terminable on 14 days notice on either side. However, the Appointing authority reserves the right of termination of her service forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying the pay and allowance for that period.

Her continuance in service is subject to:

- Qualifying for the duties prescribed for the post she holds.
- Fulfilling such other general conditions of service as may be laid down from time to time.
- Compliance to all rules and regulations as applicable to her appointment.

Her appointment is provisional and is subject to certificates pertaining to her educational qualification and community being verified through the proper channels and if the verification reveals that her claim of community and educational qualification is false, the services of the above candidate will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.

She will be governed by the newly introduced restructured defined Contribution Pension system applicable to all new entrants to Central Government Service including Railway Service with effect from 01.01.2004 in terms of Railway Board's letter No.F(E)III/2003/PNI/24 (R.B.E. No.225/03) dated 31.12.2003 and No.2004/AC-II/21/1 dated 19.02.2004 and subsequent letter thereon (circulated under PBC No.36/2004).The existing Railway Services (Pension) Rules, 1993 including commutation of Pension Rules and Extra-ordinary Pension Rules, and State Provident Fund Rules as contained in Indian Railway Establishment Code Vol.I (1985 Edition) 1995 Reprint, shall not be applicable to the above named newly recruited/appointed candidate. For the purpose of leave she will be governed by the Leave Rules as admissible and as corrected from time to time.

She will be held responsible for the care of Government money, goods and stores and any property that may be entrusted to her care in the discharge of her official duties.

In all other matters not specifically provided for in the recruitment rules, she will be governed by the provisions of the Indian Railway Establishment Code, Manuals and other extant orders as amended or issued from time to time.

She will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in this behalf from time to time.

She has declared that she is living at No.21, Rajiv Nagar, Korattur, Chennai-600076. (Not living in Government accommodation).
