

Her engagement as Substitute Bungalow Peon is subject to the following terms and conditions:

- Her engagement as Substitute Bungalow Peon is purely as Substitute for a period of 4 months.
- She is liable to be discharged without any notice, on any of the following conditions:
 - On expiry of sanction to the post held.
 - In the event of her mental or physical incapacity.
 - When the officer with whom she is attached is transferred or retired.
 - If her services are found to be unsatisfactory to the officer concerned to whom she is attached or is not required for any other reasons.
 - Unauthorized absence from duty without prior permission or intimation.
- If at any stage, the certificates submitted by her in support of her educational qualification, community details etc are found to be not genuine, she is liable to be removed from service without any notice.
- She shall be responsible for the charge and care of government money, goods and stores and all other property that may be entrusted to her.

5. Her engagement carries no claim for pension or gratuity or any absentee allowance. **She will not be eligible for any leave during the first four months.**
6. She will not be permitted to subscribe to the Provident Fund.
7. She shall conform to all rules/regulations applicable to her engagement.
8. She has declared that she is living at No.4, Sivasakthi Nagar, Nerkundram, Chennai – 600 107 (Not Living in Government accommodation).
9. Her PAN Number is DFDPP1122R.
10. In the event of the officer getting transfer to other Railways, the Substitute Bungalow Peon is also liable to be transferred to the new Railways.

She will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in this behalf from time to time.
