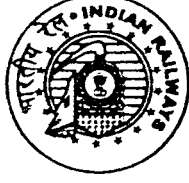

3. He will be assigned seniority in the new seniority unit to which he is transferred as per the extant orders applicable to such mutual transfer (i.e. he will retain his own seniority or take the seniority of the other whichever is lower).
2. He will not be eligible for joining time. T.A, Transfer grant, Transfer Pass etc. as the transfer is ordered at his own request.
3. He should not seek re-transfer to ICF at a later date.
4. In terms of Rule 228 of IREC Vol.I he will retain his lien at ICF until he is permanently absorbed in Southern Railway.
5. He should vacate the railway quarters if any allotted to him, within the stipulated period.
