Shri.SANTHAKUMAR.R(SC), S/o Shri.K.Ramu, (DOB: 01-06-1981, DOA : 14-09-2007) Tech.Gr.1/Fitter/C&W/RMM/MDU/southern Railway on being relieved on 23/10/2018 to carry out the inter railway mutual transfer with Shri.A.SANTHAKUMAR, Emp.No.845249, Tech.Gr.1/Fitter/MW, Shop/T.No.40/6012 of ICF, has reported at ICF on 24/10/2018. He is posted to Shop-40 as Tech.Gr.1/Fitter/MW on pay Rs.30,100/- in Level-5 w.e.f.24/10/2018 subject to usual terms and conditions as laid down for such inter railway mutual transfer.

1. He will take his seniority in the new seniority unit to which he is transferred in terms of Para 310 of IREM Vol.I as applicable to the mutual transfer ie. he will either retain his own seniority or take the seniority of A. SANTHAKUMAR, with whom he is exchanged, whichever of the two is lower.
2. He will not seek re-transfer to his parent railway at a later date.
3. He will continue to maintain his lien in C&W/MDU/S.Rly. till he is permanently absorbed in ICF.
4. He is not eligible for joining time, TA/Transfer grant, pass etc., as the transfer is ordered at his own request.
5. He will be provided Railway Quarters on his turn, as per his registration in ICF.
6. He is assigned Emp.No.880685 in I.C.F.

He has declared that he is not living in Govt./Rly. Accommodation.
