As they do not possess the technical qualification, they have to undergo 3 years training for the post of Techn.Gr-3(1year at TTC&2 years in Shop floor training).As such initially they have been deputed to TTC/ICF for 1 year training.

On completion of 1 year training at TTC, they will be further deputed for 2 years training in Shop floor. On completion of 3 years training they have to undergo trade test for the post of Techn.Gr-3. On passing trade test, they will be absorbed as regular Techn.Gr-3/Carpenter Group (CSU) (Level-2).

Their services are purely temporary, the first two years of which will be on probation. They will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction to the post which they hold or the expiry of the officiating vacancy or is due to their physical or mental incapacity or due to the removal or dismissal as disciplinary measure after compliance with the provision of Clause-2 of the Article 311 of the Constitution of India. Otherwise their services are terminable on 14 days notice on either side. However, the Appointing authority reserves the right of termination of their services forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying them the pay and allowance for that period. Their continuance in service is subject to: (a) qualifying for the duties prescribed for the post they hold. (b) fulfilling such other general conditions of service as may be laid down from time to time. (c) Compliance to all rules and regulations as applicable to her appointment.

The appointment is provisional and is subject to the Caste certificate and certificates pertaining to educational qualification being verified through the proper channels and if the verification reveals that the claim of community and educational qualification is false, the services of the above candidates will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.

They will be governed by the newly introduced restructured defined contribution pension system applicable to all new entrants to Central Government Service including Railway Service with effect from 01.01.2004 in terms of Railway Board's letter No. F(E)III/2003/PNI/24 (R.B.E. No.225/03) dated 31.12.2003 and No.2004/AC-II/21/1 dated 19.02.2004 (circulated under PBC No. 36/2004). The existing Railway Services (Pension) Rules, 1993 including commutation of Pension Rules and Extraordinary Pension Rules, and State Provident Fund Rules as contained in Indian Railway Establishment Code Vol.I (1985 Edition) 1995 Reprint, shall not be applicable to the above named newly recruited/appointed candidates. For the purpose of leave they will be governed by the Leave Rules as admissible and as corrected from time to time.

They will be held responsible for the care of Government money, goods and stores and any property that may be entrusted

to their care in the discharge of their official duties. No request for Inter-Railway Transfer will be entertained during the period of five years service.

In all other matters not specifically provided for in the recruitment rules, they will be governed by the provisions of the Indian Railway Establishment Code, Manuals and other extant orders as amended or issued from time to time. They will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in this behalf from time to time.

The above candidates been specifically recruited on Sports account by this Administration and they will have to participate in all Championships & Sports activities when required to do so by the Administration. Failure to represent the ICF Sports Association in the tournaments would tantamount to violation of Railway Service (Conduct) Rules, 1966, entailing disciplinary action under the Railway Service (D&A) Rules, 1968. They are bound by the Service Bond executed by them by which they should serve the Administration at least for a minimum period of five years.

In case if infringement/violation of the above conditions, they shall pay to the Government an amount equivalent to the salary payable for the period of 5 years.

The above candidates have declared that they are not living in any Government accommodation.
