Approval of Competent Authority is hereby communicated for the inter railway mutual transfer of Shri.BALAMURUGAN.U, Emp.No.857776 (Tech.Gr.1/Fitter/GL/Cadre), presently working as Inspector Gr.1/Ex-Cadre, Shop/T.No.42A/0143 of this Administration with Shri. HARI SINGH KUSHWAH Tech.Gr.1/Fitter/WR Shop/Carriage & Wagon Works/Perambur/Southern Railway .

Shri.BALAMURUGAN may be relieved on repatriation to Technician Gr.1/Fitter on pay Rs.30100/- in Level-5 to report to CWM/Carriage & Wagon Works/Perambur/Southern Railway to carry out the inter railway mutual transfer with Shri. HARI SINGH KUSHWAH, subject to the usual terms and conditions as laid down for such inter railway mutual transfer: -

1. He will take his seniority in the new seniority unit to which he is transferred in terms of Para 310 of IREM Vol.I. He will either retain his own seniority or take the seniority of Shri.HARI SINGH KUSHWAH, with whom he is exchanged, whichever is lower.
2. He should not seek re-transfer to his parent Railway at a later date.
3. He is not eligible for joining time, TA/Transfer grant, pass etc., as the transfer is ordered at his own request.
4. He will retain his lien in the parent Railway till such time he is absorbed permanently in the new seniority unit to which he is transferred.
5. He should vacate the Railway quarters if any allotted to him at ICF, within the stipulated period.
6. No request for back tracking of Mutual Transfer will be entertained under any circumstances in terms of Rly. Bd's Lr.No.E(NG)I-206/TR/6 dt.21.04.2006.

No DAR/Vig./SPE case is pending or contemplated against him as on date.
