Shri.B.Ramesh, Emp No.825635, Ex-Helper, Unit 18/1 had initially worked as Commission Bearer in the Catering Establishment of Southern Railway from 10.07.1990. Consequently, he was appointed as Helper Gr.II/C&W as a fresh entrant at Southern Railway w.e.f.27.09.2001. Subsequently he was transferred from Trivandrum Division, Southern Railway to ICF and taken on rolls w.e.f.02.07.2005. The services of the employee had ceased with this administration due to his demise w.e.f.14.08.2016.

An O.A.No.1217/2014 was filed by the employee before the Hon'ble CAT, Chennai bench by M.Shankar & 19 others against UOI represented by GM/Southern Railway and 3 others praying for counting of 50% services rendered by Commission Bearers in Catering Establishment in Southern Railway. Shri.B.Ramesh, Emp No.825635 was also one among the applicants in this OA while he was serving in Southern Railway and later reported at ICF on inter railway one way transfer on bottom seniority.

Hon'ble CAT Chennai has directed "that 50% of past services rendered by the applicants before they are regularized in Railway Services, till their retirement to reckon the total qualifying service for the purpose of pensionary benefits after verification of the service particulars of the applicants with reference to similarly placed persons in OA 194/2010 and pass a reasoned order. It is also needless to say that if the applicants are regularized prior to 01.01.2004 they are entitled for old pension scheme and those applicants who are regularized after 01.01.2004 they come under the new Pension Scheme."

In compliance with the Courts direction, the 50% services rendered as Commission bearer in the Catering Establishment in respect of late Shri.B.Ramesh, Ex-Helper, Shop 18/1 from 10.07.1990 to 26.09.2001 shall be counted for pensionary benefits in personam applicable to Shri.B.Ramesh alone.
