

The competent authority of this Administration has accepted his request for relieving him to take up the post of Clerk cum Typist consequent on his selection through GDCE. He is relieved from this Administration on 30.01.2019 after working hours with instruction to report to AMM/WP/GOC, on 31.01.2019 to take up appointment as Clerk cum Typist in Level-2 subject to the following conditions.

- 1.His lien will be maintained in his parent unit since he has completed his probation period of two years from the date of his appointment in the initial recruitment grade.
- 2.He will be governed by general rules and regulation about his service conditions issued by the administration from time to time.
- 3.He will not be eligible for transfer allowance, Advance of Pay, Travelling Allowance, Joining time, Transfer Pass etc as per extant rules as he is joining the new unit on his own volition.
- 4.He should surrender his RC Pass, Identity Badge and Medical Card if any he possesses before he is relieved.
- 5.He should handover all the Railway Materials in his possession before being relieved.
- 6.He should vacate the Railway quarters, if any in occupation, failing which action will be initiated against him as per extant rules.
- 7.He is governed under the New Pension Scheme – 2004.
- 8.He should not seek reversion to his parent railway at a later date.
- 9.The actual date of his joining may be advised to this office.
