In order to assist Project Directorate in Railway Board, one workcharged post of SSE in Level-7 (VI-PC-PB 9300-34800+4600 PB) was created and operated in Railway Board and the currency of it was charged to sanctioned projects at RCF/Kapurthala, upto 30.09.2014 and later charged to the sanctioned works of SSE/Mechanical/ICF from 01/10/2014 to 30/09/2015, as per of Railway Board's letter No. 2011/M(W)/964/66 dated 19/09/2016. Finance concurrence was accorded for the last extension of currency of the above one workcharged post of SSE/Mechanical in Level-7 from 01/10/2017 to 30/09/2018, vide Office Order No. PB/S2/184 DT. 08/02/2018.

Now, Finance concurrence is accorded for the extension of currency of one workcharged post of SSE/Mechanical in Level-7 (VI-PC Pay Band 9300-34800+4600 GP) for a period of two years from 01/10/2018 to 30/09/2020, for co-ordinating various projects of Mechanical Directorate, in Railway Board (as indicated in Rly Board's letter No. 2011/M(W)/964/66 dt. 05/10/2018) and chargeable to sanctioned work of ICF – viz. Establishment charges (COFMOV)/Other Rly, Executive Agency) of the Mech. Est. of the work- “Modernization for complete switch over to LHB coach manufacturing (Phase-II) in Level-7 {Pay Band Rs. 9300-34800+4600 GP}” as instructed by Railway Board.

Railway Board are requested to direct RCF to raise debit against ICF in the same month as and when the funds have been utilized, in addition to the amount already certified for the previous period of sanction, viz., upto 30/09/2018.

The pay and allowance of the incumbent of the post may be charged to the allocation P4285 1000 502CS 011 000.
