He should vacate the Railway Quarters if any under his occupation and hand over the railway material if any under his possession to his immediate supervisor.


There is no DAR/Vigilance case pending/contemplated against him. He is not undergoing any punishment as on date.

The actual date of his joining duty may be advised to this office.

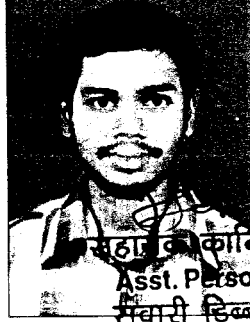
