She will not be entitled to any notice of termination of service or pay in lieu thereof if such termination is due to the expiry of the sanction of the post which she holds or the expiry of the officiating vacancy or is due to her physical or mental incapacity or due to the removal or dismissal as a disciplinary measure after compliance with the provision of Clause-2 of the Article 311 of the Constitution of India. Otherwise her service is terminable on 14 days notice on either side. However, the Appointing authority reserves the right of termination of her service forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying the pay and allowance for that period.

Her continuance in service is subject to:

- Qualifying for the duties prescribed for the post she holds.
- Fulfilling such other general conditions of service as may be laid down from time to time.
- Compliance to all rules and regulations as applicable to her appointment.

The appointment is provisional and is subject to the certificates pertaining to her educational qualification and community being verified through the proper channels and if the verification reveals that the claim of community and educational qualification is false, the services of the above candidate will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false Certificates.

She will be held responsible for the care of Government money, goods and stores and any property that may be entrusted to her care in the discharge of her official duties.

In all other matters not specifically provided for in the recruitment rules, she will be governed by the provisions of the Indian Railway Establishment Code, Manuals and other extant orders as amended or issued from time to time.

She will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in her behalf from time to time.

As per Railway Board's letter No.E (NG) II/1998/RC-1/64 Dated: 14.09.2012,

- (i) As 'Trainee', she enjoys the status of a Government servant from initial day and will be allowed all the allowances and benefits allowed to a government servant.
- (ii) She is appointed as a 'Trainee' on compassionate grounds and has to acquire the minimum educational qualifications in 5 years.
- (iii) The probation period as 'Trainee' on compassionate ground will begin only from the date she acquires minimum educational qualification and such person will be on probation for a period specified in the Recruitment Rules of the post/grade against which she is being appointed.
- (iv) She is entitled to all kinds of leave applicable to a regular Railway servant.
- (v) She shall be allowed Children Education Allowance as per the admissible rates.
- (vi) She will not be entitled for Overtime Allowance during the period she continues as 'Trainee'.
- (vii) She is appointed on compassionate grounds. Till she acquires minimum educational qualification, she will be allowed increment at normal rates in Level - 1 of 7th CPC (RSRP 2016) as the -1S scale being revised in terms of Bd's letter No.PC-VII/2016/I/6/1 dated 28.09.2017.
- (viii) She is eligible to medical benefits as available to holder of the post.

As per Railway Board's letter No.E(NG)II/2011/RR-I/11 Dated:09.12.2011,

The period spent as Trainee will not be counted as service for any purpose until she is regularized.
