
Shri. JAYAGOPI.N, Emp.No.788838, while working as Progressman/Mech/Ex-cadre, Unit-56A in Level-5 of the Mechanical Department has been compulsorily retired from service with effect from 28/11/2017 on Pay Rs.44100/-in level-5 as a disciplinary measure under DAR vide this office order No.PB/S2/CR/1928 dated 30/11/2017.

On appeal, the penalty of compulsory retirement from service ordered in respect of Shri. JAYAGOPI.N is modified to that of "reduction to lower stage by two stages i.e. from Rs.44100/- to Rs.41600/- in Level-5 of RSRPR 2016 for a period of Two Years from the date of joining duty. On restoration of penalty this will not have the effect of postponing future increments of pay".

Consequently, Shri.JAYAGOPI.N, Emp.No.788838 is reinstated as Progressman/Mech/Ex-cadre on pay Rs.41600 + 12%SP in Level-5 and posted to Shop-56A with effect from 17/12/2018.

The intervening period between the date of Compulsory retirement from service and the date of joining duty i.e. from 28/11/2017 to 16/12/2018 is treated as DIES-NON.
