Sanction has been accorded by the competent authority for payment of ₹.14,800/- (Fourteen Thousand Eight Hundred only) to Shri.Vikash Kumar, Emp.No.880474, Unit 60/A, Substitute Bungalow Peon attached to Shri.Chandra Pal, CMM/Genl, towards Composite Transfer Grant (being 80% of one month's basic pay of ₹.18500/- in Level -1 of the 7th CPC Pay Matrix (Pre-revised Pay Band-1 ₹.5200-20200 + ₹.1800/- GP) in terms of Rule 1643 of IREC Vol.II and revised rules enunciated vide RBE 103/2017 dated 24.08.2017 & RBE 117/2017 dated 01.09.2017.

The Substitute Bungalow Peon was posted in the same capacity to CMM/Genl consequent to the transfer of the Officer from Salem, Southern Railway to ICF. The Substitute Bungalow Peon had been relieved from Salem, Southern Railway on 31.08.2018 and reported in ICF on inter railway transfer and taken on rolls w.e.f. 05.09.2018 (Availing LAP from 01/09/2018 to 04/09/2018). The transfer has been necessitated consequent to the transfer of the officer to whom he has been attached to ICF.

He had been engaged by the Officer w.e.f. 27.10.2016, and granted Temporary Status on 24.02.2017. He is drawing basic pay of ₹.18500/- (Eighteen Thousand Five Hundred Only) in Level - 1 of the 7th CPC Pay Matrix (Pre-revised Pay Band ₹.5200-20200 + ₹.1800/- GP) on the date of his relief from Salem to Chennai. He has declared that he had shifted his personal effects on 30/09/2018.

In terms of Point No.12.2 of the Revised Procedure Order No.01/2016 dated 13.10.2016, Bungalow Peons are entitled for CTG and other transfer privileges as his transfer was effected due to the transfer of his officer to ICF.
