
Shri.P.RAJENDRAKUMAR (SC), Emp.No.714601, Technician Gr-2/Painter, Shop/T.No.251/7014, has been compulsorily retired from service w.e.f.18/09/2017 on pay Rs.33300 in Level-4 as a disciplinary measure under DAR vides office order No.PB/S4C/CR/1582 dated 18/09/2017.

On appeal the penalty of Compulsory Retirement from service ordered in respect of Shri.P.RAJENDRAKUMAR is modified to that of "Withholding of annual increment of pay in Level-4 of RSRPR 2016 for a period of two years. This will not have the effect of postponing the future increment of pay".

Consequently, Shri.P.RAJENDRAKUMAR, Emp.No.714601 is reinstated into service as Technician Gr-2/Painter on pay Rs.33300 in Level-4 and posted to Shop-25 with effect from 18/12/2018.

The intervening period between the date of Compulsory retirement from service and the date of joining duty i.e from 18/09/2017 to 17/12/2018 is treated as DIES-NON.
