Shri.C.SRINIVASAN, S/o.Shri.K.CHINNAPPAN, Emp.No.806215, (D.O.B.20/09/1975), (D.O.A.09/09/1997), Ex-Technician Gr.3/Fitter/GI, Shop/T.No.191/1337, was compulsorily retired from service on 28/03/2017 as a disciplinary measure vide O.O.No.PB/S4A/2/506 dt.28.03.2018. The penalty of compulsory retirement is modified by the Revising Authority and Shri.C.SRINIVASAN is re-instated into service as Helper and posted to Shop-30 (T.No.3041) on pay Rs.18,000/- in Level-1 of RSRPR-2016 on 19/12/2018 with a penalty of "Reduction at lower post as Helper at minimum of pay i.e. on pay Rs.18,000/-in Level-1 of RSRPR 2016 for a period of five years from the date of joining duty on re-instatement. On restoration of penalty, this will have the effect of postponing the future increments of pay and seniority".

The intervening period between the date of compulsory retirement from service and the date of joining duty on re-instatement i.e. from 29/03/2017 to 18/12/2018 is treated as DIES-NON.
