He is charged against the vacancy available in the Administration Department (Unit 70/A).

His engagement as Substitute Bungalow Peon is subject to the following terms and conditions:

1. His engagement as Substitute Bungalow Peon is purely as Substitute for a period of 4 months.
2. He is liable to be discharged without any notice, on any of the following conditions:
 - a) On expiry of sanction to the post held.
 - b) In the event of his mental or physical incapacity.
 - c) When the officer with whom he is attached is transferred or retired.
 - d) If his services are found to be unsatisfactory to the officer concerned to whom he is attached or is not required for any other reasons.
 - e) Unauthorized absence from duty without prior permission or intimation.
3. If at any stage, the certificates submitted by him in support of his educational qualification, community details etc are found to be not genuine, he is liable to be removed from service without any notice.
4. He shall be responsible for the charge and care of government money, goods and stores and all other property that may be entrusted to him.

5. His engagement carries no claim for pension or gratuity or any absentee allowance. **He will not be eligible for any leave during the first four months.**
6. He will not be permitted to subscribe to the Provident Fund.
7. He shall conform to all rules/regulations applicable to his engagement.
8. He has declared that he is living at 2B, 8th Street, West Thanikachalam Nagar, 'F' Block, South Kamarajar Salai, Ponniammanmedu, Ambattur, Chennai – 600110 (Not Living in Government accommodation).
9. His PAN Number is ASEP0018P.
10. In the event of the officer getting transfer to other Railways, the Substitute Bungalow Peon is also liable to be transferred to the new Railways.

He will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for such period as may be laid down in this behalf from time to time.
