3. He is not eligible for joining time, TA/DA/Transfer Pass, Composite Transfer grant etc. as the transfer is ordered at his own request.
4. He will be governed by general rules and regulations about his service conditions issued by the administration from time to time.
5. His lien will be maintained in ICF for a period of two years.
6. There is no DAR/Vigilance/SPE case pending/contemplated against the employee as on date.
7. He is residing in Railway Quarters in ICF.
