

The promotion of Smt P.Pushpa as Senior Clerk is on trial basis for a period of six months from the date of promotion and her further continuance is subject to successful completion of six months trial period.

The promoted employee as at Sl.No.1 may exercise option if she want her pay to be fixed from the date of accrual of next lower grade increments, in terms of Rule 1313 R-II, within one month from the date of promotion. Any option received after one month will not be entertained under any circumstances. She is also advised that the option once exercised shall be final.
