Smt. DEVLIS , Emp.No. 799140, Technician Gr-2/Fitter/Tool Room, Shop/T.No. 412/7020 , has been removed from service w.e.f.14/11/2016 on pay Rs.30500 in Level-4 as a disciplinary measure under DAR vide office order No. PB/S4C/04/1713 dated 15/11/2016.

On revision, the penalty of Removal from service ordered in respect of Smt.S.Devi is modified to that of "Reduction to lower post as Helper at minimum pay i.e., ₹.18000 in Level -1 of RSRPR 2016 for a period of three years from the date of joining duty on reinstatement . On restoration of penalty, this will have the effect of postponing the future increment of Pay and seniority".

Consequently, Smt. DEVLIS , Emp.No. 799140, is reinstated into service as Helper on pay of Rs.18000 in Level-1 and posted to Shop-10 with effect from 02/01/2019

The intervening period between the date of compulsory retirement from service and the date of joining duty on re-instatement i.e from 15/11/2016 to 01/01/2019 is treated as DIES-NON.
