

PAPPU KUMAR, S/O SHANKAR YADAV, Emp No: 875202, Vendor.Gr-III, Unit 90G, Date of Birth: 05/08/1991, Date of Appointment: 27/01/2016, on Pay ₹ 19700/- in Level -1 of the 7th CPC Pay Matrix (RSRP 2016) (Pre-revised Pay Band-1 ₹ 5200-20200 + ₹ 1800/- Grade Pay) of this administration has been selected for the post of Technician Gr-III in Level-2 through RRB, Mumbai against General Department Competitive Examination (GDCE) in Central Railway vide advise letter No.MTN/EM/EI/R&T/03 dated.05.02.2019.

The acceptance of the competent authority of this Administration is accorded for relieving him to take up the post of Technician Gr-III at Central Railway consequent on his selection for the post through GDCE. He is relieved from this Administration w.e.f.20.02.2019 after working hours with instruction to report to the Assistant Personnel Officer, MTN/C&W, Central Railway, Mumbai subject to the following conditions.

1. He will retain his lien in ICF until he is permanently absorbed in Central Railway, Mumbai.
2. His relief from this administration is on Technical Grounds since the employee has completed his 2 year probation period in terms of Para 1404 (ii) of the IREM Vol.I provisions.
3. He will be governed by general rules and regulation about his service conditions issued by both the administrations from time to time.
4. He will not be eligible for transfer allowance, Advance of Pay, Travelling Allowance, joining time, Transfer Pass etc as per extant rules as he is joining the new unit on his own volition.
5. He should surrender his RC Pass, Identity Badge and Medical Card if any he possesses before he is relieved.
6. He should handover all the Railway Materials in his possession before being relieved by the controlling in charge since he is operating as Vendor in this administration.
7. He should vacate the Railway quarters, if any in occupation, failing which action will be initiated against him as per extant rules.

8. If there is no intimation regarding his absorption at Central Railway, Mumbai within a period of 2 years he would be deemed to have resigned on technical grounds.
9. He is covered under New Pension Scheme and his Pran No.110067232958.
10. The actual date of his joining and assuming higher responsibilities may be advised to this office.
11. There are no DAR/Vigilance cases pending or contemplated against the above named employee.
