The actual date of his joining duty may be advised to this office.

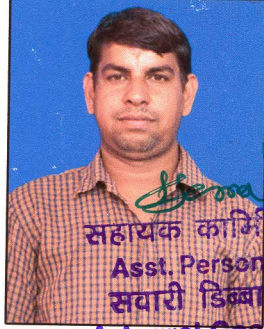
