Date of Appointment: 21/06/2017 on Pay ₹ 19100/- in Level -1 of the 7th CPC Pay Matrix (RSRP 2016) (Pre-revised Pay Band-1 ₹ 5200-20200 + ₹ 1800/- Grade Pay) of this administration has been selected for the post of Clerk-cum-typist in Level-2 through RRB, Chennai against General Department Competitive Examination (GDCE) in Southern Railway vide advise letter No.U/P.563/XII/PG/Gr.C dated.05.02.2019.

The acceptance of the competent authority of this Administration is accorded for relieving him to take up the post of Clerk-cum-typist at Southern Railway consequent on his selection for the post through GDCE. He is relieved from this Administration w.e.f.22.02.2019 after working hours with instruction to report to the Assistant Personnel Officer/T, Engineering Department, Madurai Division, Southern Railway, subject to the following conditions.

1. His lien will not be maintained in his parent unit since he has not completed his probation period of two years from the date of his appointment in the initial recruitment grade.
2. He will be governed by general rules and regulation about his service conditions issued by the administration from time to time.
3. He will not be eligible for transfer allowance, Advance of Pay, Travelling Allowance, Joining time, Transfer Pass etc as per extant rules as he is joining the new unit on his own volition.
4. He should surrender his RC Pass, Identity Badge and Medical Card if any he possesses before he is relieved.
5. He should handover all the Railway Materials in his possession before being relieved.
6. He should vacate the Railway quarters, if any in occupation, failing which action will be initiated against him as per extant rules.
7. He should not seek reversion to his parent railway at a later date.
8. The actual date of his joining may be advised to this office.
9. He is governed under the New Pension Scheme – 2004 and his Pran No.110191526855

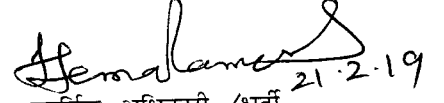
