The inter-railway mutual transfer of Sri.V.Kanagaraj(OBC),Emp.No.821642, Technician.Grade-1/Welder, Shop/TK.No.212/6450 of I.C.F., Chennai, on pay Rs.34900/-(LEVEL-5) in exchange with Sri.Lakhan Yadav(UR), Tech.Gr.1/ Welder of GOC/Trichy/Southern Railway has been approved by the Competent Authority viz.CWM/GOC communicated vide WPO/GOC letter No.WPO/GOC/S.Railway/ GPB(A)34-IRMT-Vol.IV dated 23/01/2019. He may be relieved forthwith to report to WPO/GOC/Trichy/S.Rly to carry out his inter railway mutual transfer, subject to the usual terms and conditions as laid down for such inter railway mutual transfer as shown below:

- 1) He will take the seniority in the new seniority unit to which he is transferred as per para-310 of IREM.Vol.I, applicable to mutual transfer I.e., he will either retain his own seniority or take the seniority of the other in the new seniority unit whichever is lower.
- 2) He is not eligible for joining time, TA/Transfer Grant as the transfer is ordered at his own request.
- 3) Lien will be maintained in ICF till he is permanently absorbed in GOC/Southern Railway.
- 4) He should not seek retransfer to ICF at a later date.
- 5) The date of reporting of Sri.V.Kanagaraj to be intimated to this office.
- 6) There is no DAR/Vigilance/SPE case pending or contemplated against the above employee on the date of relief.

The above inter railway mutual transfer has the approval of the Competent Authority in ICF.
