The under mentioned candidate who has been Re-Appointed as a Fresh Entrant in the Erstwhile Group "D" (Now Group C) post vide GM's order No.PB/S/DAR/801490/UA dated 09.02.2019 is appointed and posted as Trainee Vendor in Level 1 of the 7th CPC Matrix on pay Rs.18000/-, as shown below, vice Smt. Nirmala Devi, Emp.No.879262 who has been promoted as Clerk-cum-cashier vide Office Order No.PB/S1A/325 dated 18.02.2019.

He will not be entitled to any notice of termination of service or pay in lieu thereof if such termination is due to the expiry of the sanction of the post which he holds or the expiry of the officiating vacancy or is due to his physical or mental incapacity or due to the removal or dismissal as a disciplinary measure after compliance with the provision of Clause-2 of the Article 311 of the Constitution of India. Otherwise his service is terminable on 14 days notice on either side. However, the Appointing authority reserves the right of termination of his service forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying the pay and allowance for that period.

His continuance in service is subject to:

- Qualifying for the duties prescribed for the post he holds.
- Fulfilling such other general conditions of service as may be laid down from time to time.
- Compliance to all rules and regulations as applicable to his appointment.

The appointment is provisional and is subject to the certificates pertaining to his educational qualification and community being verified through the proper channels and if the verification reveals that the claim of community and educational qualification is false, the services of the above candidate will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false Certificates.

He will be held responsible for the care of Government money, goods and stores and any property that may be entrusted to his care in the discharge of his official duties.

In all other matters not specifically provided for in the recruitment rules, he will be governed by the provisions of the Indian Railway Establishment Code, Manuals and other extant orders as amended or issued from time to time.

He will if so required, be liable for Military service in the Railway Engineering Units of the Territorial Army for a period of 7 years in the Territorial Army Service and 8 years in the Territorial Army reserve or for the such period as may be laid down in this behalf from time to time.

As Trainee Vendor he is working in the canteen, he is not eligible for free food and beverages in the canteen and that he should pay for them if he wants such facilities.


He has declared his residential address as G-3, Karpaga Vinayagar Homes, Rahendra Prasad Street, Oragadam, Ambattur, Chennai 600 053 (not living in Government accommodation).

As per Railway Board's letter No.E (NG) II/1998/RC-1/64 Dated: 14.09.2012,

- (i) As 'Trainee', he enjoys the status of a Government servant from initial day and will be allowed all the allowances and benefits allowed to a government servant.
- (ii) He is appointed as a 'Trainee' on compassionate grounds and has to acquire the minimum educational qualifications in 5 years.
- (iii) The probation period as 'Trainee' on compassionate ground will begin only from the date he acquires minimum educational qualification and such person will be on probation for a period specified in the Recruitment Rules of the post/grade against which he is being appointed.
- (iv) He is entitled to all kinds of leave applicable to a regular Railway servant.
- (v) He shall be allowed Children Education Allowance as per the admissible rates.
- (vi) He will not be entitled for Overtime Allowance during the period he continues as 'Trainee'.
- (vii) He is appointed on compassionate grounds. Till he acquires minimum educational qualification, he will be allowed increment at normal rates in Level - 1 of 7th CPC (RSRP 2016) as the -1S scale being revised in terms of Bd's letter No.PC-VII/2016/I/6/1 dated 28.09.2017.
- (viii) He is eligible to medical benefits as available to holder of the post.

As per Railway Board's letter No.E(NG)II/2011/RR-I/11 Dated:09.12.2011,

The period spent as Trainee will not be counted as service for any purpose until he is regularized.
