The above financial upgradation is subject to the following conditions:-

1. There will be no change in the designation or the nature of duty performed. The status of the employees remains unchanged.

2.The financial upgradation under MACP scheme is purely personal to them and shall have no relevance for his seniority position, ie., this will not confer any seniority benefit.

3.Grant of higher grade pay under the MACP scheme shall be conditional to the fact that the employee while accepting the said benefits shall be deemed to have given his unqualified acceptance for regular promotion on occurrence of vacancy subsequently.

4.The employee at Sl. No.2 may exercise option if he wants his pay to be fixed from the date of accrual of next lower grade increment, in terms of Rule 1313 R-II, within one month from the date of financial upgradation. Any option received after one month will not be entertained under any circumstances. He is also advised that the option once exercised shall be final.

5.The financial upgradation entitles the employee concerned to avail certain benefits which are linked to the pay drawn by the employee.

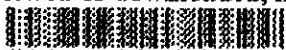
