On revision, the penalty of Removal from service ordered in respect of Shri.K.KARTHIKEYAN is modified to that of "Penalty of withholding of increment of pay in Level-2 of RSRPR 2016 for a period of Three years . On restoration of penalty, this will not have the effect of postponing the future increment of Pay".

Consequently, Shri.K.KARTHIKEYAN, Emp.No.858445, is reinstated into service as Technician.Gr-3(FMW)/Fitter(CSU) on pay of Rs.19900 in Level-2 and posted to Shop-40 with effect from 03/04/2019.
