They shall continue to work as Bungalow Peons to their attached officers.


Their services are purely temporary, the first two years of which is on probation. They will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction of the post which they hold or due to the expiry of the officiating vacancy or is due to their physical or mental incapacity or due to removal or dismissal as a disciplinary measure after compliance with the provision of Clause-2 of the Article 311 of the Constitution of India. Otherwise their services are terminable on 14 days' notice on either side. However the Appointing Authority reserves the right of termination of their service forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying them the pay and allowance for that period.

Their continuance in service is subject to them fulfilling such other general conditions of service, as the case may be as laid down from time to time. The earlier appointment of the above candidates will not confer on them any prescriptive right for seniority etc, over others who are placed above them in the order of selection and whose appointments are being delayed for one reason or the other.

If at any later date the certificates submitted by them in support of their educational, community details etc are found not to be genuine they are liable to be removed from service without notice. They will if required, be liable for military service in the Railway Engineering Units of the Territorial Army for a period of seven years and eight years in the Territorial Army Reserve or for such period as may be laid down in this behalf from time to time.

They shall be governed by the NEW PENSION SCHEME in terms of Board's Letter No.F(E)III/2003/PNI/24 dated 31.12.2003.

The above regularisation has the approval of competent authority.
