The request of Shri. TULAGAPU PURNACHANDRA RAO, Emp.No.854495, Technician Grade-3/Welder, Shop/Tk.No.22/1572 of I.C.F., Chennai, on Pay Rs.22400/- in LEVEL-2 for inter railway oneway transfer to WALTAIR DIVISION / East Coast Railway on reversion as HELPER in Level-1 on bottom seniority has been approved by the Competent Authority viz. DRM/WAT communicated vide letter No.WPV/PB/Trf.Cell/ IROT (IN)/ Tech.III/2019 dated 22/03/2019. He may be relieved with immediate effect with instructions to report to SR.DPO/WAT to carry out the inter railway oneway transfer subject to the usual terms and conditions as laid down for such inter railway one way transfer as shown below:

- 1) He will take his seniority in the new seniority unit as per Para 312 of IREM Vol.I i.e. he will rank junior to all the permanent/temporary/ officiating HELPER in Level-1 on the date of joining in Waltair Division/East Coast Railway
- 2) He should not seek retransfer to his parent railway at a later date.
- 3) He is not eligible for joining time, as Transfer grant, pass etc., as the transfer is ordered at his own request.
- 4) He will retain his lien in ICF, Chennai till such time he is permanently absorbed in Waltair Division/East Coast Railway.

He should vacate the railway quarters if any allotted to him, within the stipulated period. NPS number of Shri. TULAGAPU PURNACHANDRA RAO is 110042757873. There is no DAR/Vigilance /SPE case pending or contemplated against the above employee.
