Hon'ble Supreme Court of India, in the SLP (C) 31236/2017 (civil Appeal No.2926/2019) filed by I.C.F., against the order of Hon'ble High Court/Madras dated 06/04/2017 in WP.No.38328 in the MACP case of Sri.K.Ganesan, Ex.Technician Gr-1, has granted leave for the SLP and passed order on 12-03-2019 directing in partial modification of High Court order that the respondent Sri.K.Ganesan to be granted benefit of Rs.4200 GP NOTIONALLY, only for the purpose of computation of pension and no monetary payment apart from the enhanced pension amount need to be given.
