
OFFICE ORDER No.PB/S4B/01/686

The request of Shri. A.RAJKUMAR,(OBC) Emp.No.842291, Technician Grade-3/Welder, Shop/Tk.No.191/1341 of I.C.F, Chennai, on Pay Rs.25200/- in LEVEL-2 for Inter Railway Oneway Transfer to MADURAI DIVISION / Southern Railway as Technician.Gr.3 in Level-2 on bottom seniority has been approved by the Competent Authority viz. DPO/MDU communicated vide letter No..U/P676/IV/IRT/One way/SSE/JE-C&W dated 05/04/2019. He may be relieved with immediate effect with instructions to report to SR.DPO/MDU to carry out the Inter Railway Oneway Transfer subject to the usual terms and conditions as laid down for such Inter Railway One way Transfer as shown below:

- 1) He will take his seniority in the new seniority unit as per Para 312 of IREM Vol.I i.e. he will rank junior to all the permanent/temporary/ officiating Technician.Gr.3 in Level-2 on the date of joining in Madurai Division/Southern Railway
- 2) He should not seek retransfer to his parent railway at a later date.
- 3) He is not eligible for joining time, as Transfer grant, pass etc., as the transfer is ordered at his own request.
- 4) He will retain his lien in ICF, Chennai till such time he is permanently absorbed in Madurai Division/Southern Railway.

He should vacate the railway quarters if any allotted to him, within the stipulated period. NPS number of Shri A.RAJKUMAR is 110071853188. There is no DAR/Vigilance /SPE case pending or contemplated against the above employee.
