1. He will take his seniority in the new seniority unit to which he is transferred in terms of Para 310 of IREM Vol.I as applicable to the mutual transfer ie. he will either retain his own seniority or take the seniority of Shri.KURAMSETTI DURGA RAO, with whom he is exchanged, whichever of the two is lower.
2. He will not seek re-transfer to his parent railway at a later date.
3. He will continue to maintain his lien in CWM/CRS/TPTY S.C.Rly. till such time he is permanently absorbed in ICF.
4. He is not eligible for joining time, TA/Transfer grant, pass etc., as the transfer is ordered at his own request.
5. He will be provided Railway Quarters on his turn, as per his registration in ICF.
6. He is assigned Emp.No.881661 in I.C.F.

He has declared that he is not living in Government/Railway Accommodation.
