They will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to the expiry of the sanction of the post which they hold or the expiry of the officiating vacancy or due to his/her physical or mental incapacity or due to the removal or dismissal as a disciplinary measure after compliance with the provision of Clause 2 of the Article 311 of the Constitution of India. Otherwise their services are terminable on 14 days notice. However, the appointing authority reserves the right of termination of their service forthwith or before the expiry of the stipulated period of notice or unexpired portion thereof, by paying them the pay and allowance for that period.
