The above posting /promotion will take effect from the date on which the employees report to Ex-cadre post of Inspection/Mechanical as the case may be.

The employees selected and posted to the Ex-cadre post of Inspector/Ex-cadre/Mech. will retain their position in their parent cadre and will be considered for promotion to higher grades therein along with others, according to seniority positions in the cadre. Selection to this ex-cadre post would not confer on them any right for consideration for promotion to the same or higher grades in their parent cadre on the shop-floor. They will be retained in the Ex-cadre post for 3 to 5 years depending upon the exigencies of service and will be allowed to return to the parent cadre earlier than three years only on promotion. As and when they are reverted from the Ex-cadre post of Inspector/Mech to the Shop-floor, they will revert to their due position in the cadre therein.
