The Mutual Transfer is subject to the flowing conditions:

- 1 Shri.Deepak Kumar will be assigned seniority in the new seniority unit to which he is transferred as per the extant orders applicable to such mutual transfer (i.e. he will retain his own seniority or take the seniority of the other whichever is lower)
2. He will be governed by general rules and regulations about his service Conditions issued by the administration from time to time.
3. He is not eligible for joining time, TA, Transfer grant, Transfer Pass etc., as the transfer is ordered at his/her own request.
